#### 5.1 Spruce Grove Lodge

Sign installation was approved at the December  $5^{th}$  Council meeting. Once funding is announced for SGL a celebratory sign raising event will be organized.

CMHC notified MHF that the Contributions Only program closed due to exhaustion of funds. MHF can apply for loan funding through the National Co-Investment Fund which requires a Class B budget. Administration recommended advancing the project to meet the requirements of the Class B budget through RFP process for Architectural Prime Consultant services.

Independent Consultant, Derek Weiss submitted an application on behalf of MHF for the Alberta Affordable Housing Partnership program.

The City of Spruce Grove will hear the third reading of bylaw C-1162-21 – land use bylaw amendment, regarding the rezoning of the property, on February 27, 2023. This proposal affects the future site of the Spruce Grove lodge.

### 5.2 RAB (Rent Assistance Benefit) Program
