BUSINESS LICENCE BYLAW AMENDMENT - MOBILE VENDING

WHEREAS, pursuant to the *Municipal Government Act,* R.S.A. 2000 c M-26, a municipality may provide for the licensing, regulation and control of business by passing a business licence bylaw within the City of Spruce Grove;

AND WHEREAS, the City of Spruce Grove has established such business licencing in C-975-16 - Business Licence Bylaw;

AND WHEREAS, pursuant to the *Municipal Government Act*, R.S.A. 2000, c M-26 and amendments thereto, a council has the power to amend enacted bylaws;

AND WHEREAS, the City of Spruce Grove wishes to amend C-975-16 - Business Licence Bylaw;

NOW THEREFORE, the Council for the City of Spruce Grove, duly assembled, hereby enacts as follows:

- 1. Bylaw C-975-16, be amended as follows:
 - 1.1 By adding the following definition after section 3.8:
 - 3.8.1 "Mobile Vending Business" means a vending business that is carried on from a non-permanent, mobile facility, including but not limited to a motor vehicle, trailer, cart or cycle, within the City. Sales and services from this business type are limited to those offered at the mobile facility and cannot extend beyond.
 - 1.2 By adding in section 4.2(e) the following in bold:
 - 4.2(e) Inspect any business to determine whether it is in compliance with the bylaw **and any Business Licence conditions**;
 - 1.3 By adding in section 9.1 the following in bold:
 - 9.1 All **Resident Business or Non-Resident Business** Business Licence are valid from January 1 of a given year until 23:59:59 on December 31 of the same calendar year, unless the Business Licence is revoked by the Business Licence Inspector.
 - 1.4 By adding the following section after section 9.1:

- 9.1.1 All Temporary Business Licences are valid for a specified duration of a given year, unless the Business Licence is revoked by the Business Licence Inspector.
- 1.5 By adding in section 9.3 the following in bold:
 - 9.3 A Business Licence may be considered invalid for any Business that fails to comply with federal or provincial legislation or licensing, fails to comply with any condition of a Business Licence, or fails to comply with a bylaw of the City of Spruce Grove.
- 1.6 By adding in section 12.1 the following in bold and deleting the following in strikethrough:
 - A Temporary Business Licence shall be issued for a bBusiness, 12.1 including Mobile Vending Business, that intends to conduct business within the City for a period of 72 consecutive hours or less, whether resident or non-resident on a temporary basis. A Temporary Business Licence shall be valid for a specific time period within the calendar year and may be issued with conditions.
- 1.7 By deleting section 12.2 in its entirety:
 - 12.2 A business which exceed the 72 hour time limit for its operations must submit an application for a resident or non-resident business licence.
- 2. This amending bylaw shall be consolidated into Bylaw C-975-16.
- 3. This bylaw shall come into force and effect on May 1, 2023.
