TITLE: 2023 First Quarter Report and Reporting Dashboard

**DIVISION:** Corporate Services

### **SUMMARY:**

The quarterly report is an integrated report focused on key strategic, operational, and financial results for the City. The report includes an update on the activities of the organization, its capital projects, programs and services, key trending data and financial results for the period ended March 31, 2023.

New for the first quarter report for 2023 is the launch of a community facing reporting dashboard. This dashboard has been built on the City's website to monitor and share important information about our community and the City's programs and services. Data sets included on the dashboard contain either the latest available data or time specific data, and include a chart with historical data, a trend indicator, reporting frequency, as well as a description of the indicator, how the data is measured, and why it is important. ### **BACKGROUND / ANALYSIS:**

### **2023 First Quarter Report**

Administration has prepared the attached 2023 First Quarter Report to update Council and the community on the activities of the organization, services provided to the community, trending data, and insight into the work being undertaken as it relates to the themes in Council's 2022-2025 Strategic Plan. The report also provides financial highlights for the quarter and includes a summary of the revenue and expenses for Municipal, Utility, and Developer

operations as well as an improved capital project summary that consolidates all capital projects into one report for greater transparency, clearer communication, and ease of understanding.

### **Reporting Dashboard**

In addition to the quarterly report, a community facing reporting dashboard has been launched on the City's website (<a href="www.sprucegrove.org/dashboard">www.sprucegrove.org/dashboard</a>). This dashboard has been built to monitor and share important information about the community and the City's programs and services. Data sets included on the dashboard contain either the latest available data or time-specific data, and include a chart with historical data, a trend indicator, reporting frequency, as well as a description of the indicator, how the data is measured, and why it is important. At this time, the dashboard data is static, and the goal is to provide updates quarterly with available data.

Data sets that were selected in this first phase of the dashboard launch are those that have already been regularly reported as part of the quarterly and annual reporting processes. Additional data sets will be investigated as part of the next phase of the dashboard development and added to the dashboard as City systems are built and matured, particularly around community social needs and planning and development. The intent is for the reporting dashboard to continuously evolve and integrate the ability for real time data reporting.

# IMPLEMENTATION / COMMUNICATION:

The quarterly report is intended to update Council and the community on the activities of the organization, services provided to the community, trending data, and insight into the work being undertaken as it relates to the themes in Council's 2022-2025 Strategic Plan. The report is also provided to ensure transparency in financial reporting. This report is generated for the first quarter of the current fiscal year.

Administration has evolved capital reporting in this quarterly report by consolidating all capital projects into one report for greater transparency, clearer communication, and ease of understanding.

## **IMPACTS:**

The reporting dashboard and this quarterly report, along with the financial summaries, are intended to provide information to continuously enhance communication and transparency.
