#### 4. ADMINISTRATIVE UPDATES

#### 5. BUSINESS ITEMS

#### a. Spruce Grove Roadway Speed Limit Study

Morrison Hershfield Limited conducted the Spruce Grove Roadway Speed Limit Study throughout the latter half of 2022 and provided recommendations to the City in May 2023. Administration presented the findings to the Committee.

2023-20 Moved by Ken Mark that the Committee strongly endorses and supports the blanket speed limit of 40 km/h on all local roads recommended in the Spruce Grove Roadway Speed Limit Study as well as all other recommendations included in the report.

#### b. Street / Intersection Lighting

The Committee has discussed that some intersections within the city are poorly lighted or not at all. Administration had indicated that upgrades/repairs to these intersections are occurring and for 2023 the locations that will be upgraded are as follows:

- 1. North/south crosswalk on Grove Drive at Hilldowns Drive.
- 2. North/south crosswalk on Grove Drive west of King Street.
- East/west crosswalk on Century Road between Grove Drive and Beaumont Ave.

# c. Community Standards Bylaw

Public consultation is set to occur from May 15 to July 9 on the Community Standards Bylaw (CSB) and Urban Farming project. The consultation involves City staff and members of City Council attending community events to provide information on the consultation and distributing post cards and business cards. These cards will have a QR code to the online survey that will be used to collect the feedback on various topics. Hard copies of the survey will be available for the public to complete on site as well.



# d. <u>Canadian Association of Road Safety Professionals Conference</u>

Committee member, Ken Mark, inquired if there is an opportunity for Committee members to attend the Canadian Association of Road Safety Professionals conference.

Administration provided information to the Committee to aid in this discussion.

2023-21 Moved by Ken Mark that the Committee recommends a budget be allocated for the Committee for education and awareness initiatives.
