MUTUAL AID AGREEMENT

Being a by-law of the Town of Spruce Grove in the Province of Alberta for the entering into of a peace-time emergency mutual aid agreement with the City of St. Albert.

WHEREAS the City of St. Albert has made provisions to enter into a peace-time emergency mutual aid agreement with the Town of Spruce Grove;

AND WHEREAS the Council of the Town of Spruce Grove deem it advisable and expedient to enter into said agreement;

AND WHEREAS Section of the Municipal Government Act, Revised Statutes of Alberta 1980, and amendments thereto, authorizes the Council of the Town of Spruce Grove to enter into agreements with other Municipalities;

NOW THEREFORE, the Municipal Council of the Town of . Spruce Grove, duly assembled, enacts as follows:

- THAT the Town of Spruce Grove, together with the City of St. Albert, enter into a peacetime emergency mutual aid agreement, which is attached hereto and forming part of this bylaw, and hereinafter referred to as Schedule "A"
- THAT Schedule "A" may be modified by resolution, providing mutual consent in writing is received by both parties in said agreement.
- 3. THAT the Mayor and the Municipal Secretary are hereby authorized and empowered to execute said agreement under appropriate seal of the Town of Spruce Grove.
- 4. THAT this by-law shall come into force and effect upon final reading.

MUTUAL AID AGREEMENT

SCHEDULE "A"

PEACE TIME EMERGENCY MUTUAL AID AGREEMENT

BETWEEN the incorporated municipalities listed here:

- 1. City of St. Albert
- 2. Town of Spruce Grove

WHEREAS a peace time emergency could affect any municipality to such a degree that local municipal resources would be inadequate to cope with the situation;

AND WHEREAS the above-named municipalities wish to make prearrangements for speedy emergency action in support of either municipality in the group which may be affected or threatened by peacetime disaster or emergency and requires assistance;

THEREFORE, the above named municipalities agree as follows:

In the event of a fire or other peace-time disaster or emergency within the corporate boundaries of either the Town or the City, each party mutually agrees to provide assistance to the other under the following terms and conditions:

- The Fire Chief or designate of the municipality which is called upon to provide assistance will determine what, if any, manpower and equipment will be sent to the other municipality.
- If manpower and equipment is provided the Fire Chief or designate of the municipality providing assistance shall have first call on his own manpower and equipment in the event that such manpower and equipment are required to return to the municipality providing assistance.
- 3. The Town agrees that it will indemnify and hold harmless the City for all claims, debts, actions or causes of action which may be brought against the City or any employee for failing to respond to a call for assistance or for the negligence of any employee of the City arising out of any attendance at any call in the Town.
- 4. The City agrees that Town for all claims, debts, actions or causes of action which may be brought against the Town or any employee for failing to respond to a call for employee of the Town arising out of any attendance at any call in the City.

- 5. This agreement comes into force on 19, and may be reviewed yearly thereafter, until its time of termination, Five (5) years from date of ratification.
- 6. Either party may withdraw from the agreement by giving 30 days notice of termination to the other party.
