

## **REQUEST FOR DECISION**

**MEETING DATE:** February 26, 2024

**TITLE:** C-1286-23 - Omnibus Area Structure Plans Repealing Bylaw

**DIVISION:** Sustainable Growth and Development Services

#### **SUMMARY:**

The repealing of several Area Structure Plans (ASP) that are no longer needed to guide development of lands within the City of Spruce Grove as the lands are fully built out are proposed. First reading of the Repealing Bylaw is before Council for consideration.

### **PROPOSED MOTION:**

THAT first reading be given to C-1286-23 - Omnibus Area Structure Plans Repealing Bylaw.

# **BACKGROUND / ANALYSIS:**

Administration is in the process of streamlining its planning documents and has determined that the ASPs, as amended, listed below are no longer needed to guide development. The lands within these ASPs are fully built-out and have no undistricted future development lands.

A statutory public hearing, advertised per the requirements of the *Municipal Government Act*, will be held prior to consideration of second reading.

## **IMPLEMENTATION / COMMUNICATION:**

The ASPs will be repealed and removed from the City's website.

#### **IMPACTS:**

Approval of this bylaw will streamline planning processes as these ASPs and their associated policies are no longer required to regulate land development.
