

## **REQUEST FOR DECISION**

**MEETING DATE:** February 26, 2024

TITLE: Updated 2022 - 2025 Strategic Plan

**DIVISION:** Strategic and Communication Services

### **SUMMARY:**

The 2022 - 2025 Strategic Plan has been updated including amendments based on feedback received from Council at their January 2024 retreat as part of the annual Strategic Plan review process.

### PROPOSED MOTION:

THAT the updated 2022 - 2025 Strategic Plan be approved.

## **BACKGROUND / ANALYSIS:**

The 2022 - 2025 City of Spruce Grove Strategic Plan reflects the vision Council has for the community, as identified in their commitment statement, and is the roadmap for their current term (2021 - 2025). As well, the Strategic Plan guides Administration in their work and sets the priorities of the City for the four years of the plan.

Some of the goals, objectives and actions within the Strategic Plan are more immediate and short term, while others are longer term and will contribute to the outcomes of future Councils. Each goal, objective, and action that requires further investment are considered and assessed through the City's annual corporate planning process.

As a living document, the Strategic Plan is reviewed annually to ensure it continues to capture the priorities of Council. At a retreat in February 2023, Council and Administration discussed proposed amendments and priorities, following which, Council made minor amendments to the 2022 - 2025 Strategic Plan which were approved in March 2023 (Attachment 1).

A similar process was followed for the second annual review of the strategic plan. A retreat was held in January 2024 where Council and Administration discussed proposed amendments and priorities. Based on the feedback provided by Council, Administration is recommending the following amendments as reflected in the updated Strategic Plan:

Council was engaged at their January 2024 Council Retreat to provide feedback on the amendments proposed by Administration to be reflected in the Strategic Plan.


# **IMPLEMENTATION / COMMUNICATION:**

## **IMPACTS:**

Updating the Strategic Plan reflects the living document nature of the Strategic Plan and ensures the Strategic Plan continues to capture the priorities of Council.

Should the updated Strategic Plan be approved by Council, the total number of actions would be reduced to 85 actions as a result of three actions being combined or removed from the Strategic Plan. Additionally, 11 actions would be reprioritized from 2022/23 to 2024 and another two actions from 2024 to 2025. The following is a breakdown of the current status and the proposed amendments:
