TITLE: C-1200-22 – Omnibus Repealing Bylaw – Third Reading

DIVISION: Corporate Services

SUMMARY:

As part of the bylaw and policy review project approved in the 2022-2024 Corporate Plan, Administration is bringing forward 18 bylaws to be repealed. These bylaws have either expired or are no longer required as they are either superseded by provincial legislation, matured systems, and/or process within the municipality or are no longer necessary to enable the provision of a service.

PROPOSED MOTION:

THAT third reading be given to C-1200-22 – Omnibus Repealing Bylaw.

BACKGROUND / ANALYSIS:

Serving a maturing, growing city calls for systems that inform evidence-based decision-making. Administration is in the process of implementing various systems, policies, and processes in an effort to continuously improve transparency, and program and service delivery. One of the projects supporting this initiative is a two-year bylaw and policy review.

The work is being approached in phases. The first phase has focused on bylaws and corporate policies that are either superseded by provincial legislation, matured systems, and/or process within the municipality, or no longer necessary to enable the provision of a service.

As part of this phase, Council gave first and second reading to C-1200-22, Omnibus Repealing Bylaw on May 9, 2022.

The chart below identifies bylaws contained in C-1200-22 that Administration is recommending be repealed along with reasoning to support the recommendation.

Council may approve the bylaw, or alternatively, may defeat the motion for third reading and choose to defeat this bylaw. Based on subject matter consultations and research, this is not suggested. Administration supports this bylaw. No concerns or questions were raised by Council during first and second reading.

CONSULTATION / ENGAGEMENT:

The project lead in Integrated Planning and Strategic Services has worked in partnership with the City Clerk's Office and subject matter experts in respective departments to determine those bylaws that would be appropriate to recommend for repeal. Research and consultation with departments, as well as consultation with legal counsel confirm no legislative gaps will result from the repealing of the bylaws referenced above.

IMPLEMENTATION / COMMUNICATION:

Upon third reading and signing of the bylaw, Administration will communicate the repeal to all staff and remove those bylaws that may be on the City website from circulation.
