The City Clerk read an email submitted by Shane Manuel of Spruce Grove regarding his concerns about the amount of noise and lawlessness occurring at the Fuhr Sports Park. He inquired about what tangible measures can be taken to resolve the issues.

The General Manager of Community and Protective Services encouraged the resident to continue to report the issues to the RCMP and Protective Services. He advised that all reported issues are tracked and reviewed for proactive options and priorities.
