# Who We Serve: Lodge

- Functionally independent seniors who need supports for daily living tasks like meals, housekeeping and laundry, and who may not want to live alone
- Low to moderate income seniors who cannot afford private options
- Residents must be left with a minimum of \$322 monthly income after paying rent







# Why We Need Spruce Grove Lodge

- Lodge Assistance Program (LAP) provincial subsidy provided to housing management bodies to reduce rents for tenants with incomes below a set threshold
- Waitlist for lodge accommodations
- Rents align with seniors benefits
- Seniors can remain in our communities to access services they need
- Community benefits from additional jobs

### Steps Taken


- Housing Needs Assessment completed in 2020
- Business Case and Development Options Spruce Grove Lodge completed in 2021
- Municipal presentations and consultations
- Land acquisition completed
- Successful in gaining CMHC seed funding
- Partnered with Colliers Project Leaders for analysis, master plan, and conceptual drawings
- Advocating for funding with the Province

- Lodges require additional square footage to accommodate for common area space such as commercial kitchen, laundry, dining room, etc.
